<b>Duration of time</b>	Up to 3 years
<b>Country/(ies) or region supported</b>	State of Pará, Brazil
<b>Description/qualifications of eligible participants</b>	<p><b>For the Proposer/Coordinator in the State of Pará:</b></p> <ul style="list-style-type: none"> <li>a) Must hold a doctoral degree.</li> <li>b) Must be a Brazilian citizen or a foreigner legally residing in the country, with a fixed residence in the State of Pará.</li> <li>c) Must be the principal investigator and coordinator in the State of Pará.</li> <li>d) Must have an effective employment contract with a scientific, technological, and innovation institution (ICT) or a higher education institution (IES), public or private non-profit, headquartered in the State of Pará, which must be maintained throughout the entire project execution period.</li> <li>e) Must have the approval of the vice-rector for research or equivalent to carry out the project.</li> <li>f) Must not be a public servant or service provider assigned to Fapespa and must not have a direct or collateral kinship up to the 3rd degree of kinship with public servants or service providers assigned to it.</li> <li>g) Must be responsible for taking all measures involving special ethical or legal permits and authorizations necessary for the execution of the object of this instrument, as well as the custody of these documents and their availability in case of proof (Example: experiments involving human beings; access to protected areas; access to genetic, cultural, and traditional associated knowledge, access to indigenous, quilombola, and traditional community areas, and others, in the case where the nature of the object requires it);</li> <li>h) Must not be the principal investigator and/or coordinator of more than one proposal in this call.</li> <li>i) Must not have more than one ongoing research project at Fapespa.</li> </ul> <p><b>For the Executing Institution:</b></p> <ul style="list-style-type: none"> <li>a) Must be an ICT and/or HEI, public or private non-profit, headquartered in the state of Pará.</li> <li>b) Must be registered in the CNPq Institution</li> </ul>

<b>Stipulations for the maximum number of researchers in the consortium</b>	Each consortium is limited to one researcher who can receive funding from FAPESPA. While other researchers can be included in the project team, they will not be considered for financial support.
<b>Type of contribution + amount of contribution (R\$)</b>	Monetary  Total amount contribution of R\$1 million (approx. EUR 161,5 k)
<b>Maximum amount that can be requested per project or by researcher (R\$)</b>	Up to R\$ 500k per project (Approx. EUR 80,750 K)
<b>Restrictions for use of funds</b>	Resources must be exclusively allocated to other current expenses - operating costs.  Costs characterized as capital expenditures or investments (e.g., equipment, construction, and the like) will not be funded.
<b>Specific themes within the Call</b>	All topics in this call are eligible for Fapespa funding.
<b>Where to submit proposal</b>	Directly on the Belmont Forum website: <a href="http://www.bfgo.org">www.bfgo.org</a>  Approved proposals must be submitted by the proposer/coordinator in the state of Pará, with a specific work plan, through the <a href="#">Fapespa Platform</a> . Additional documents will be requested at the time of proposal submission on the Fapespa Platform.
<b>Additional information</b>	Being compliant with FAPESPA (technical and financial accountability of other projects), as well as having a Regular Status with the Federal and State Revenue Services, CADIN, and SIAFE at the time of proposal submission on the Fapespa Platform, during the execution of the grant agreement, and at the time of financial disbursements, is a mandatory condition and may result in disqualification.  Consortium partners based in the state of Pará must follow the specific guidelines mentioned above, or the entire consortium may be affected.  In case of doubts, please contact FAPESPA through the designated contact point.  Templates of specific documents will be made available on the Fapespa Platform.
